School District of the City of Highland Park Request for Proof of Surety Bond – City Treasurer

WHEREAS, the Treasurer of the City of Highland Park is charged with the receipt, custody, and disbursement of public funds, including the collection and allocation of tax revenues to the School District of the City of Highland Park; and

WHEREAS, pursuant to the provisions of **Michigan Compiled Laws (MCL) 129.201 et seq.** and applicable requirements of Wayne County, all public officers entrusted with public funds are required to provide a surety bond conditioned on the faithful performance of their duties and the proper accounting of all monies received; and

WHEREAS, the Board of Education of the School District of the City of Highland Park has a fiduciary duty to ensure that tax revenues allocated to the District are safeguarded in accordance with law; and

WHEREAS, the Board of Education finds it in the best interests of the District to obtain written verification and documentation confirming that the Treasurer of the City of Highland Park, Ms. Lisa Stolarski, is properly bonded in compliance with statutory requirements.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the School District of the City of Highland Park hereby formally requests that the City Treasurer provide documentation verifying the existence of a valid surety bond, including the bond number, effective date, and coverage limits; and

BE IT FURTHER RESOLVED, that such documentation shall be transmitted to the School District no later than **[insert deadline, e.g., 15 business days from the date of this Resolution]**; and

BE IT FINALLY RESOLVED, that the Chief Educational Officer (or designee) is hereby directed to transmit this Resolution, together with a formal letter of request, to the Treasurer of the City of Highland Park, Ms. Lisa Stolarski, at 12050 Woodward Avenue, Highland Park, Michigan 48203.
